Consolidating Newborn Screening Efforts in the Asia Pacific Region

Last June 4-5, 2010. representatives from various Asian countries gathered at the Traders Hotel Manila for the "2nd Workshop Consolidating Newborn Screening Efforts in the Asia Pacific Region." This was a follow-up to the assembly in 2008 where key policy service providers. researchers, and consumer advocates met to firm up the following strategies:

- 1. Identify the current status of newborn screening and related researches within the South East Asia and Western Pacific Regions;
- delivery health care research infrastructure needs for maximizing research/service collaborations;
- 3. Identify strategies developing regional and international collaborative research groups; and
- 4. Define research activities emanating from newborn screening that can complement collaborations existing assess resource needs, identify available resources, and develop information about possible resources.

As part of the workshop, participating countries (Bangladesh, action steps. Philippine PEAS Tool Revised

To better address the Newborn Screening Program's issues and concerns as well as other operational challenges, the Department of Health and the Newborn Screening Reference Center established the Philippine Performance Evaluation and Assessment Scheme (PPEAS).

This is a tool that provides specific directions for Centers for Health Development (CHDs), Newborn Screening Facilities (NSFs) and Newborn Screening Centers (NSCs) in their efforts to increase coverage and serve as framework for data gathering that is vital to obtaining a realistic picture of newborn screening program implementation.

While the Philippine PEAS is patterned after the US PEAS, it is grounded on the realities of the Philippine health care delivery systems. Particularly, the Philippine PEAS is anchored on the provisions of Newborn Screening Act of 2004, the strategic framework and the manual of operations of the National Comprehensive Newborn Screening System.

The PEAS tool evolves as the program advances. For the last four years, DOH and NSRC have been using the same Philippine PEAS Tool to monitor the program. Hence, both entities conducted the PEAS Tool Review Workshop on April 9 to 11, 2010 at the Summit Ridge Hotel, Tagaytay City. The review had the

following objectives: to evaluate if the tool is practical; assess if the current PEAS measures what it needs to measure; gauge if the indicators are relevant to the present day needs of the program; and recommend measures for improvement.

She reviewed the proper collection and handling of specimen for screening and confirmatory testing. Together with Ms. Joanna Abigail B. Decano-Terrado, they discussed the factors that affect the performance of a newborn screening facility. To inspire the group, Ms. Leticia Carillo, NBS Coordinator of the Jaime Berces Memorial Hospital in Tabaco City, Albay, one of the awardees of the 2009 NBS recognition in Manila, presented the hospital's best practice using the word "CODE" that stands for C-omply, O-bligation, D-o your Best, and E-valuate. Team collaboration was also emphasized. Using the CODE formula, they were able to maintain an NBS coverage of above 90%.

On the part of the Catanduanes Provincial Health Office, a representative shared that clinical instructors of Catanduanes State University were challenged to include Newborn Screening in their subjects/topics. This is to strengthen the advocacy and, at the same time, enable their nursing students to learn the essential benefits of NBS.

The Center for Health Development-Autonomous Region in Muslim Mindanao (ARMM), in collaboration with the Department of Health and NSC-Mindanao, held the Training of Trainers on Newborn Screening on April 12-16, 2010 in Davao City. Two batches of health workers from government and private hospitals and rural health units (RHUs) were trained. Each batch was allocated two and half days of training. In attendance were nurses, midwives, doctors, medical technologists, several chiefs of hospitals from Basilan, Lanao del Sur, Maguindanao, Marawi City, Sulu and Tawi-Tawi. Ms. Aster Lynn Sur of the Institute of Human Genetics, served as lead facilitator. The actual sample collection was performed at the Southern Philippines Medical Center.

The training aimed to equip the health workers on newborn screening and intensify the awareness of health providers on increasing newborn screening coverage in ARMM. Issues, problems and solutions in implementing the program were also discussed. At the end of the activity, all health facilities not yet categorized as a newborn screening facility submitted their membership forms to CHD-ARMM. (A. Matuan)

DAVAO'S G6PD SUPPORT GROUP FORMED

On June 8, 2010, about 100 parents gathered together at the Mahogany Room of the Out Patient Department-JICA Building, Southern Philippines Medical Center to attend the first G6PD Deficiency Support Group Forum in Davao City.

The parents were from Davao City, Panabo City, Comval Province, Davao del Sur, General Santos City, Caraga and Sultan Kudarat. Mindanao's only pediatric geneticist and unit head of Newborn Screening Center-Mindanao, Dr. Conchita G. Abarquez, discussed the facts and cleared the myths on the G6PD Deficiency disorder. Dr. Abarquez's lecture made the parents aware of the nature and effects of the disorder and provided a venue for discussion and sharing of experiences.

Due to the overwhelming support of the parents, a set of officers were elected that same day to lead the Davao's Parents Support Group on G6PD Deficiency. The elected officers were Ana Theresa Basilio, president; Charlie Casane, vice-president; Eastern de

BDH adopted a scheme called *People Empowerment Serving Others* more widely known as the PESO for Health program. PESO is a community-based insurance program which aims to ensure quality, equitable, and accessible healthcare to its beneficiaries. This was made even stronger with the support of the participating local government units of STA. BAYABAS (Sta. Catalina, Bayawan City, Basay) Health Zone. Each LGU allocates fund for the healthcare needs of its constituents. With the help of the PESO Program, Bayawan District Hospital was able to screen babies from indigent families and made newborn screening available to everyone.

NSC-V Conducts Favismo — A Seminar on G6PD Deficiency

It was an afternoon of learning and interaction as the Newborn Screening Center – Visayas (NSCV) sponsored a two-hour symposium on G6PD Deficiency on May 28, 2010 at the West Visayas State University - Rehearsal Room The seminar was spearheaded by Dominic Buensalido, Project Development Officer of NSCV.

There were 143 attendees composed of parents, babies with G6PD Deficiency, and health workers consisting of nurses, doctors and midwives.

Dr. Ma. Lita Fe Paclibar, pediatric hematologist and oncologist, served as resource speaker for the said event. She gave a comprehensive lecture on G6PD deficiency, providing information on disease complications and management.

Glucose-6-Phosphate Dehydrogenase (G6PD) Deficiency is an x-linked recessive hereditary disease characterized by abnormally low levels of G6PD, an enzyme important in the metabolism of red blood cells. Individuals with the disease may exhibit hemolytic anemia, where there is an abnormal breakdown of red blood cells (RBCs) either in the blood vessels or elsewhere in the body. This in response to a number of causes, most commonly infection or exposure to certain medications or chemicals and food. Because G6PD deficiency is the most common human enzyme defect, awareness is very important to avoid possible triggering factors that may lead to complications.

An open forum between the parents and Dr. Paclibar highlighted the importance of preventive care and early detection. The seminar aimed to educate not only the parents but also the health workers and the community on the nature of the disorder. This is the second G6PD symposium conducted by NSCV with Dr. J Edgar Winston Posecion, DPPS as unit head. (*S Catedral*)

Visits to Newborn Screening Facilities in Marinduque

The Newborn Screening Center-NIH and the Extension Office of the Center for Health and Development 4B (MIMAROPA) in Marinduque visited four Newborn Screening Facilities in the province from June 3 to 4, 2010. Visited were the Rural Health Unit – Gasan, Dr. Damian J. Reyes Memorial Hospital, Sta. Cruz District Hospital and Torrijos Municipal Hospital. The visit addressed concerns and reviewed the implementation of NBS in the said facilities. The monitoring team also visited Rural Health Units of Buenavista, Torrijos and Boac, health facilities that are not yet implementing newborn screening. RHU-Buenavista had already submitted its institutional membership form and is sending blood samples for newborn screening. CHD 4B plans to conduct trainings in the remaining health units and for all the midwives in Marinduque as a means to increase the NBS coverage of the province.

1st Consultative Meeting in Romblon

The 1st Consultative Cluster Meeting in Romblon was held on June 11, 2010 at the Rencio's Resort in Odiongan. The five Newborn Screening Facilities, namely, Don Modesto Formilleza Sr. Memorial Hospital, Romblon District Hospital, Romblon Provincial Hospital, San Jose District Hospital-Romblon, and Tablas Island District Hospital were in full attendance. Mrs. Luderico Gertrudes is a midwife and owner of Well-Family Midwife Clinic - Gertrudes, one of the recipients of the 2009 Exemplary Performance Award given to health facilities with 90% or above newborn screening coverage for 2007-2008 during the celebration of Newborn Screening Week.

WFMC-Gertrudes provides newborn screening among other basic maternal and child health services and maintains various brands of health care products. It is part of the Well-Family Midwife Clinic Partnerships Foundation, Inc. (WFPI), a foundation formed by WFMC midwives and their partner NGOs to sustain their business and social development operations.

The clinic is one of few successful birthing homes implementing newborn screening in Metro Manila. It is one of three Well-Family Midwife Clinics with commendable newborn screening coverage along with WFMC - Cattleya and WFMC - Enriquez.

With a monthly average of 36 deliveries, WFMC-Gertrudes is able to screen 93% of its total deliveries. Mrs. Gertrudes makes sure that all expectant mothers coming to her clinic during their prenatal visits are given essential information and fully understand the benefits of newborn screening. She has been an active advocate of NBS since 2005 and is now part of the Pool of Trainers for Midwives. (*V Mendoza*)
