FAQ

- 1 Do I earn professional credits for attending the convention?**
Continuing Professional Development (CPD) units have been requested for the convention participants from the PRC for Midwives, Nurses, Physicians, Medical Technologists, Chemists, and Nutritionist-Dietitians.
- 2 How much is the registration fee (does not include accommodation)?**
Php 4,000 (until September 15)
Php 4,500 (payments made Sept 15 onwards)
- 3 What are the registration details?**

Fill out the registration form by scanning the QR code or clicking the register button below. Attach a clear scanned copy of the validated deposit slip indicating the name(s) of the attendee(s), agency being represented, and bank or branch where the deposit was made.
- 4 What is included in my registration fee?**
Your convention registration fee includes admission to the convention hall and exhibit area, certificate of attendance, meals for the two-day event (October 7-8: AM snacks, Lunch, PM snacks), and convention kit.
- 5 Will there be an onsite registration on October 7?**
There will be no onsite registration.
- 6 What time will the doors open on October 7?**
Doors open at 7 am.
- 7 Where will I claim the official receipt?**
Claim OR at the Secretariat Desk during the convention. Kindly bring the printed deposit/ transaction slip as proof of payment along with a valid ID.
- 8 How do I cancel my convention registration?**
Cancellation requests must be made in writing, signed by the registered participants, and sent by fax at (02) 82476008 or email nbsconvention@newbornscreening.ph. Requests for received at least two (2) weeks before the event are eligible for a refund of 75% of the registration fee net of the processing fee. Those who received less than two (2) weeks until the first day of the event (October 7) are eligible for a refund of only 50% off the registration fee net of the processing fee. Requests received on the second day of the event (October 8) onwards will no longer be refunded.
- 9 Can I send a representative if I cannot make it to the event?**
Replacement will be accepted for pre-registered participants. An authorization letter and photocopy of the ID of the non-attending participant must be presented.
